


OUTCOMES MATTER


Mrs. Glass is 79-year-old female that was diagnosed in the hospital for a fracture of the right patella. Mrs. Glass underwent an ORIF repair of the right patella and was on a very strict NWB restriction of the right patella. Mrs. Glass was admitted to Park Manor of South Belt on July 21st, 2023.

Mrs. Glass was evaluated by both Physical and Occupational Therapy. The initial physical therapy assessment indicated that Mrs. Glass required moderate assistance for bed mobility and total assistance for gait and transfers. During her initial evaluation she could not walk and was not able to put weight on the right leg. Occupational Therapy's initial assessment indicated Mrs. Glass required minimal assistance for upper body dressing however required total assistance for lower body dressing and toileting. Physical Therapy and Occupational Therapy created plans of care that were individualized for Mrs. Glass.

Prior to her hospitalization, she was able to complete all daily activities with no assistance. Mrs. Glass is a very caring, hardworking, and sweet individual. She is visually impaired but was still persistent and willing to do therapy. Mrs. Glass' goal was to be able to receive as much therapy as she can to return home with her daughter. If Mrs. Glass did not participate in physical and occupational therapy, she would have lack of coordination, muscle weakness, and be dependent with her transfers, gait, and ADLs.

After Mrs. Glass worked with skilled physical and occupational rehabilitation, she demonstrates significant improvements in her functional mobility and ability to perform all activities of daily living. Mrs. Glass improved her ability for her bed mobility and transfers to stand by assist. She was now able to walk 10ft with rolling walker with minimal to moderate assistance to assist with transfers. Lower dressing, toileting, and putting on footwear improved minimal assistance. With the great amount of progress Mrs. Glass made at Park Manor of South Belt, she was now qualified and recommended to go to an inpatient rehab for more intensive therapy. Mrs. Glass was discharged to a different inpatient rehab facility to improve her physical therapy after 29 days at Park Manor of South Belt. We are so proud of the progress she made at Park Manor of South Belt and wish her a successful recovery through her rehab journey!





MDS Section GG Functional Scores

06 - Independent

Completes the activity by him/herself with no assistance from a helper

05- Setup or clean-up assistance

Helper sets up or cleans up; patient completes activity. Helper assists only prior to or following the activity.

04 - Supervision or touching assistance

Helper provides verbal cues and/or touching/steadying and/or contact guard assistance as patient completes activity. Assistance may be provided throughout the activity or intermittently.

03 - Partial/moderate assistance

 $Helper\ does\ LESS\ THAN\ HALF\ the\ effort.\ Helper\ lifts,\ holds,\ or\ supports\ trunk\ or\ limbs,\ but\ provides\ less\ than\ half\ the\ effort.$

02 - Substantial/maximal assistance

Helper does MORE THAN HALF the effort. Helper lifts or holds trunk or limbs and provides more than half the effort.

01 - Dependent

Helper does ALL of the effort. Patient does none of the effort to complete the activity. Or the assistance of 2 or more helpers is required for the patient to complete the activity.
