


OUTCOMES MATTER


Mr. Steen is 76-year-old male came with severe gangrene on his right 4th toe, that later had to be surgically removed. He was admitted to Park Manor of South Belt on August 27th, 2023.

Mr. Steen was evaluated by both Physical and Occupational Therapy. The initial physical therapy assessment indicated that Mr. Steen required minimum assistance with bed mobility, transfers, and walking. Occupational Therapy's initial assessment indicated that Mr. Steen required minimum assistance with toileting, body dressing, and putting on his shoes. Physical Therapy and Occupational Therapy created plans of care that were individualized for Mr. Steen, who worked with both physical therapy and occupational therapy to obtain the strength needed to improve his independence. Prior to his hospitalization, he was able to complete all daily activities independently, with no assistance.

Initially, Mr. Steen was poorly motivated and feeling down because he was at the facility and not at home. After a week of therapy, his mindset changed and was very excited about participating in therapy. Mr. Steen participated and looked forward to group therapy on the days the therapy team provided group therapy. He was highly motivated and very encouraging towards all the other patients in group therapy as well. He knew his goal was to get stronger and to go home. His whole perspective and attitude changed towards therapy. He was already up in bed right after breakfast and ready to start the day. Mr. Steen always walking up and down the halls, smiling and showing everyone how much better he had improved with walking.

After Mr. Steen skilled physical rehabilitation, he demonstrates significant improvements in his functional mobility and ability to perform all activities of daily living. Mr. Steen was walking over 200' without a device. He was able to do all tasks independently such as dressing, toileting, transfers, and gait. Mr. Steen was able to be discharged from the facility after 12 days stay at Park Manor of South Belt and return home with the support of his family. Most of all, Mr. Steen was highly motivated and happy with the progress he made at Park Manor or South Belt with the support from his awesome therapy team!





MDS Section GG Functional Scores

06 - Independent Completes the activity by him/herself with no assistance from a helper
05- Setup or clean-up assistance
Helper sets up or cleans up; patient completes activity. Helper assists
only prior to or following the activity.
04 - Supervision or touching assistance
Helper provides verbal cues and/or touching/steadying and/or contact guard
assistance as patient completes activity. Assistance may be provided
throughout the activity or intermittently.
03 - Partial/moderate assistance
Helper does LESS THAN HALF the effort. Helper lifts, holds, or supports
trunk or limbs, but provides less than half the effort.
02 - Substantial/maximal assistance
Helper does MORE THAN HALF the effort. Helper lifts or holds trunk
or limbs and provides more than half the effort.
01 - Dependent
Helper does ALL of the effort. Patient does none of the effort to
complete the activity. Or the assistance of 2 or more helpers is required
for the patient to complete the activity.
